WHEREAS, the Boylan Heights Improvement Association, Incorporated, which represents the citizenship of said community and development, did, on April 28, 1926, at a meeting of said Association, pass resolutions authorizing the officers of said Association to deed the property hereinafter described to the School Committee of Raleigh Township, Wake County, North Carolina, for the purpose of said School Committee to erect on said property a school building; and whereas, the Commissioners of the City of Raleigh, have passed resolutions authorizing the School Committee of Raleigh Township, Wake County, North Carolina, to take title to said property for school purpose

and whereas, the parties of the first part, except The Boylan Heights Improvement Association, Incorporated, are property owners. in said Boylan Heights Development and community.

NOW, THEREFORE, for and in consideration of the sum of One dollar(\$1.00) and other good and valuable consideration passing from said School Committee of Raleigh Township, Wake County, North Carolina, to the parties of the first part, the receipt of which is hereby acknowledged, the parties of the first part do hereby bargain, sell and convey to said School Committee of Raleigh Township, Wake County, North Carolina, its successors, ^{and assigns,} for school purposes only, that certain parcel or block of land, lying and being in Boylan Heights, City of Raleigh, Wake County, North Carolina, and known, described and designated on the map of said development, which appears in book of maps 1885, page #14, as Boylan Springs Park, and which is more fully described as follows:
