 Boylan of the City of Raleigh in the State of North Carolina  
 of the one part, and Thomas Henderson of City of Raleigh  
 of the State aforesaid of the other part, witnesses that  
 the said William Boylan for and in consideration of  
 the sum of Three thousand dollars to him in hand paid  
 by the said Thomas Henderson the Receipt whereof the said  
 William Boylan doth hereby acknowledge hath given granted  
 Bargained and sold aliened and confirmed by these presents  
 doth give grant bargain and sell alien and confirmed unto  
 the said Thomas Henderson his heirs and assigns forever  
 all that Lot of Ground situate lying and being in the  
 City of Raleigh and known in the plan of said City as  
 No One Hundred and Ninety seven (197) and bounded as  
 follows Beginning at a Stake at the intersection of Hillsborough  
 and McDowell Streets running North two Hundred and ten feet  
 to Edenton Street thence East one Hundred and forty feet to the  
 said street to a Stake thence South two Hundred and ten feet  
 to a Stake on Hillsborough Street thence West with Hillsborough  
 Street one Hundred and forty feet to the beginning containing two  
 Chings of the above mentioned Lot No One Hundred and ninety seven
